






TERMS & CONDITIONS

The above is an estimate based on inspection and does not cover additional parts or labor which may be required after the work has been started. Occasionally worn or damaged parts are discovered which may not have been evident on the first inspection. Because of this, the above prices are not guaranteed. Quotations on parts and labor are current and subject to change.

I hereby authorize the above repair work to be done along with necessary material, and hereby grant you and/or your employees permission to operate the motor vehicle here in described on streets, highways, or elsewhere for the purpose of testing and/or inspection. An express mechanic's lien is hereby acknowledged on the above motor vehicle to secure the amount of cost incurred by Premier Truck Group in collecting amounts owed for repairs on the above vehicle. I do hereby make, constitute, and appoint you and/or your employees as my true lawful attorney for me and in my name, place, and stead to ask, demand, collect, sign for, and receive all such sums of money which are or shall be due, my name to all checks, drafts, and/or negotiable instruments related to or arising out of work done by you and/or your employees on the above mentioned motor vehicle.

- 1. **No Insurance.** We (Premier Truck Group) do not insure or otherwise protect your property from theft, fire, lot damage, vandalism, hail, or other acts of God or third parties. We strongly suggest that you lock your vehicle, trailer at all times, and take all valuable personal property with you.
- 2. **Sublet.** We may need to sublet services related to your repair to other vendors. When you authorize us to complete the repair, you authorize us to sublet all or portions of that repair to other vendors.
- 3. **Payment.** All charges for repairs, including labor and materials, are due at or before the time we tender the vehicle to you. We may tender the vehicle to you through a phone call, mail, email, or any other means of communication that shows, upon payment, we are returning the vehicle to your custody. If any charges remain unpaid for 30 days, we may hire attorneys to help with collection and completion of abandonment form, and you are responsible for paying those attorney's fees. Further, we will charge you interest monthly on all past due amounts at a rate of 18% per annum.
- 4. **Storage Charge**. If you do not take custody of the vehicle within 3 days after we tender the vehicle to you, we will charge you a parking lot fee of \$50.00 per day.
 - 5. I authorize and acknowledge the use of aftermarket parts during the repair of my vehicle.
- 6. **Vehicle Return.** You authorize us to return the vehicle to (a) you, (b) any person that presents this receipt, or (c) if you do not own the vehicle, any person the owner communicates to us is authorized to take custody of the vehicle.
- 7. **Lien.** You acknowledge that we will have a lien on the vehicle for all charges related to your vehicle (labor, materials, storage, attorney's fees, etc.); if your authorization is required by law, you authorize us to place a lien on the vehicle for all charges related to your vehicle. You authorize us to take all lawful actions to collect unpaid charges.

- 8. **Minimum Diagnostic Charge**. If your vehicle requires diagnosis, we will charge up to 2 hours of the applicable posted labor rate, plus a hook-up fee, shop supplies, and taxes.
- 9. Factory Warranty. We do not guarantee that any repairs you request will be covered by your manufacturer warranty. We do not issue your warranty; we are merely a factory-authorized warranty repair facility. We will do our best to determine your warranty coverage prior to the repair, and we will submit to the manufacturer repairs that we believe qualify for manufacturer warranty for coverage. But the manufacturer may deny your claim. In the event the manufacturer denies your claim, you agree that you are fully responsible for all charges incurred.
- 10. **Workmanship Warranty; Disclaimer.** We warranty labor and/or workmanship for 30 days following the completion of repair. No claim will be honored past the stated 30 day period. We hereby disclaim any further warranties either express or implied, including any implied warranty of merchantability or fitness for a particular purpose, and we neither assume nor authorize any other person to assume for us any liability in connection with the sale of the parts. In no event are we liable to you or any third-party for any indirect, special, punitive, incidental, or consequential damage connected to, or arising out of, our work on your vehicle whether the damage arises from breach of contract or tort or whether we have been previously advised of the possibility of such damage. If we are found liable to you for any damage, our damages are limited to the replacement of parts and/or the labor cost of repeating the service.
- 11. **Repair Authorization.** You grant us permission to operate the vehicle on streets and elsewhere for the purposes of esting and inspecting the vehicle; we are not liable for any damage caused by a pre-existing condition during such testing and inspection. You are the owner or an agent of the owner of the vehicle and you authorize us to complete the repairs listed above and any other repairs that you or the vehicle owner, by any means, later authorize.
