







Description: Driver door open interior view.





View from the driver seat of the instrument panel and dash board.





Front right corner.











Description: Rear left tire.





Rear right tire.









Description: Side angle of the front left.







Description: Backside of the rear left cab.





Description: Underside of beneath the left of the cab.





lower front right.





corner close up.






