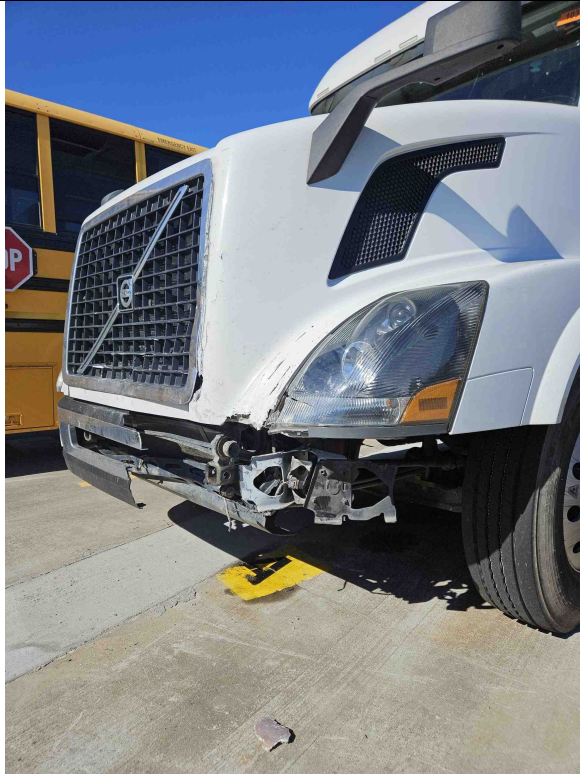

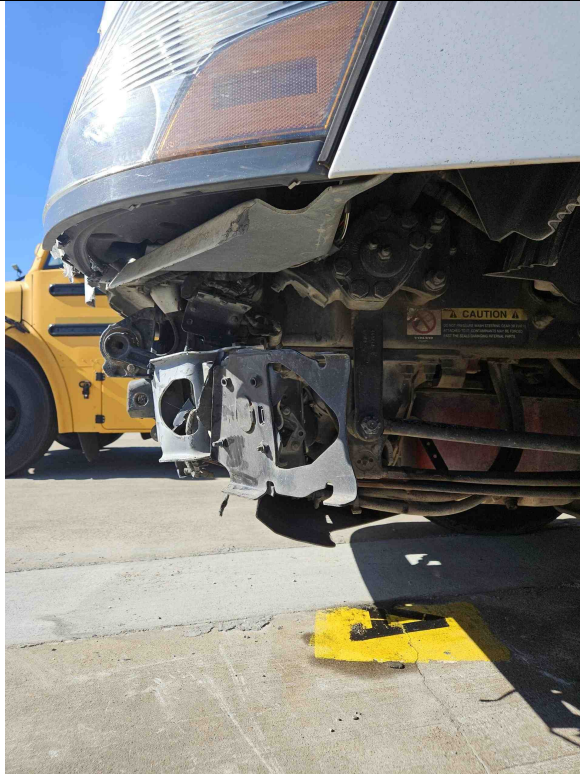

Headlight Damage

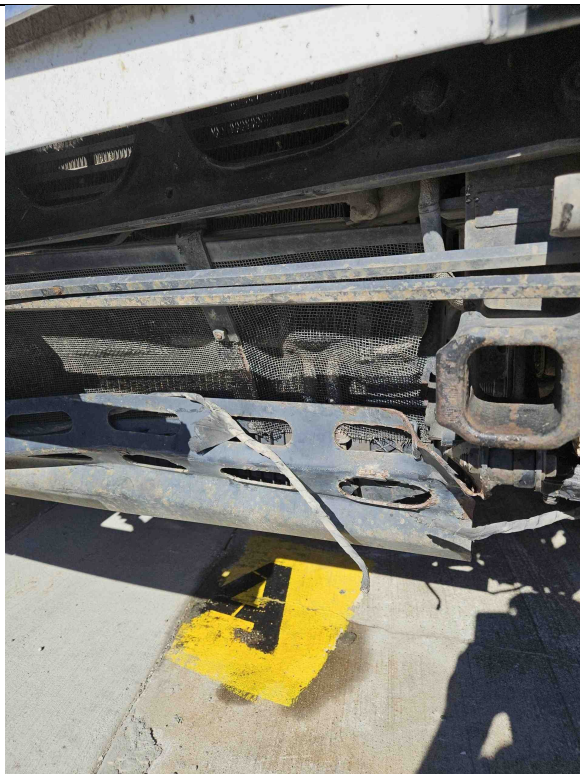

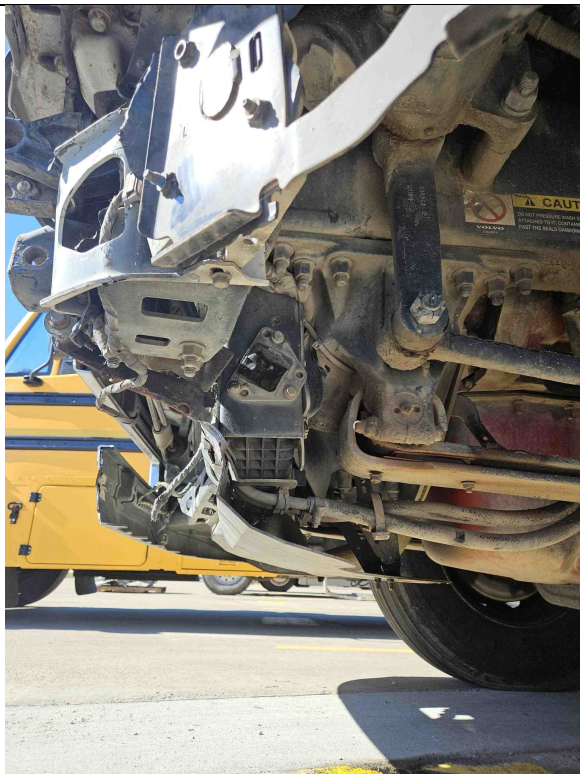

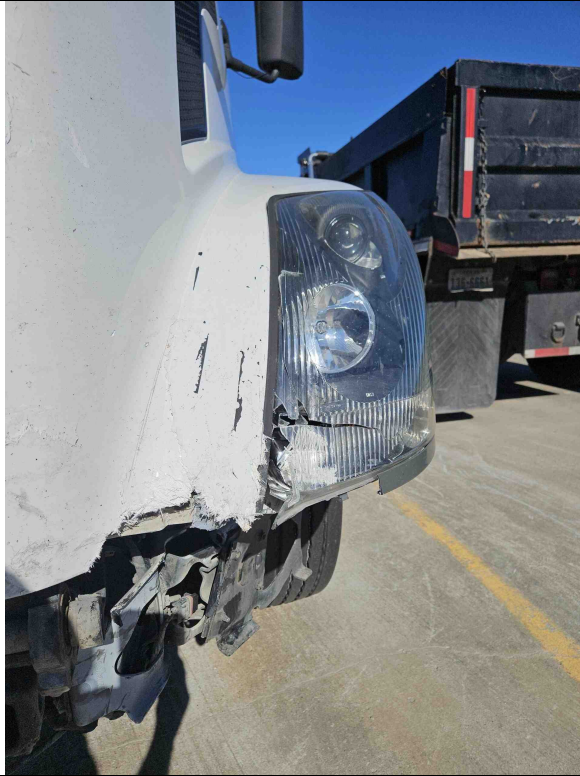

Under Hood

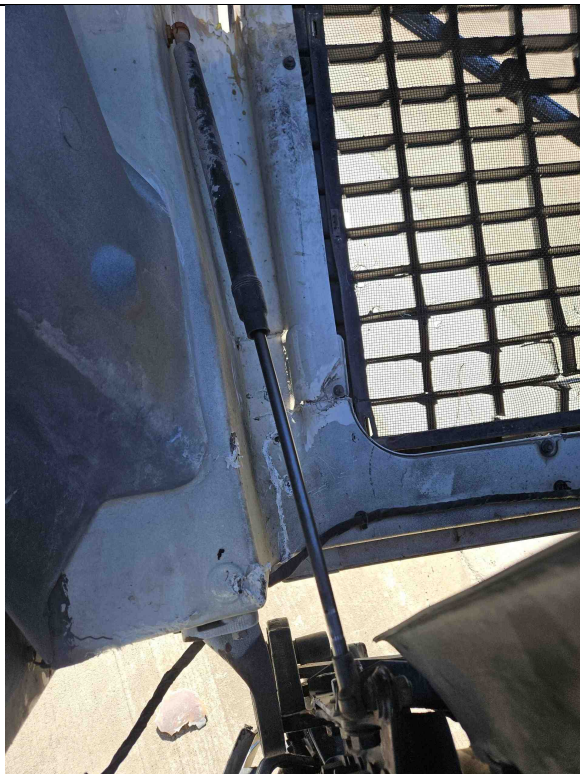

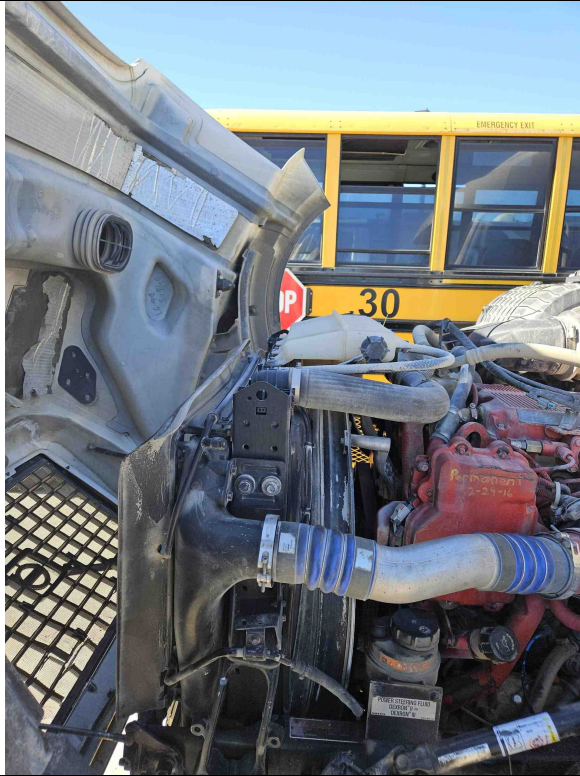

View

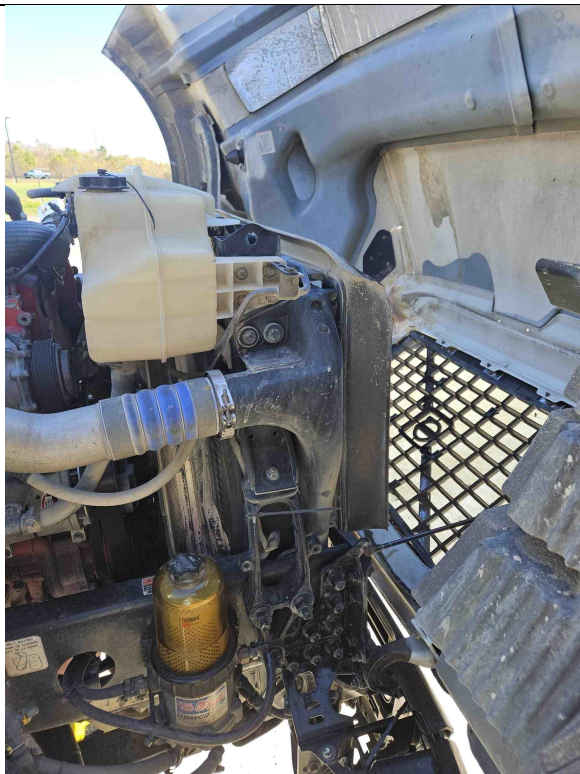

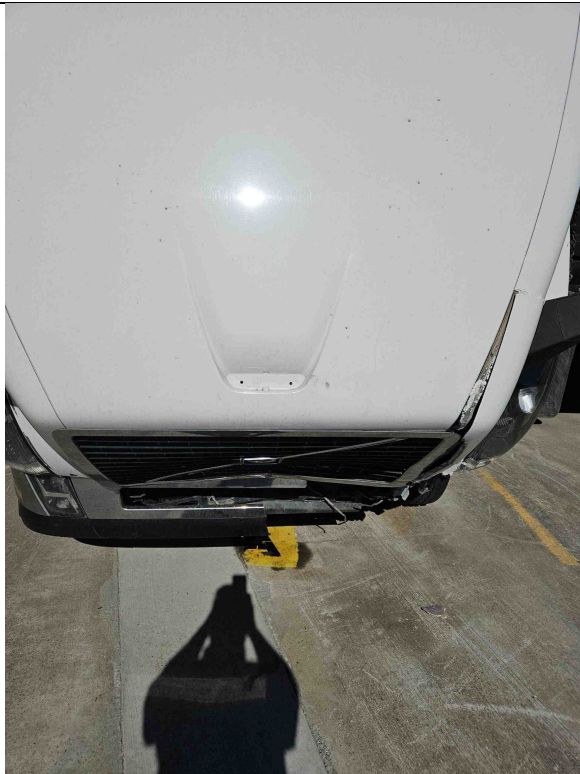

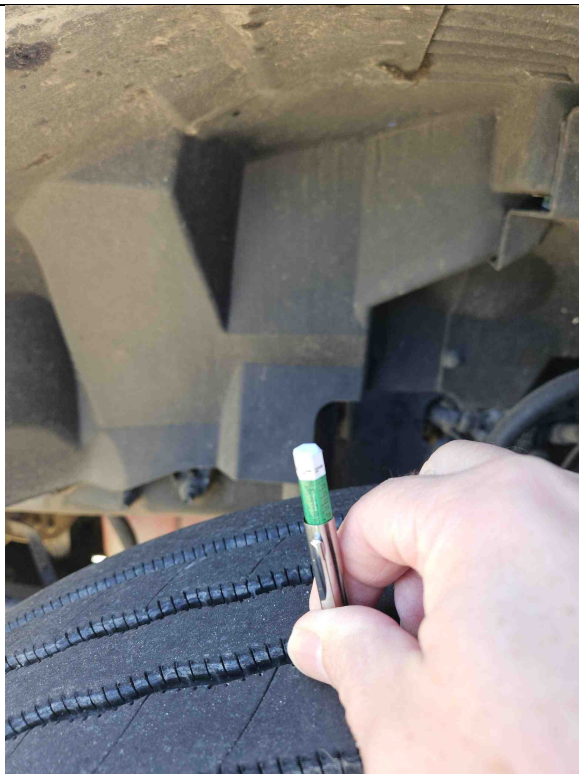

Drive Tires

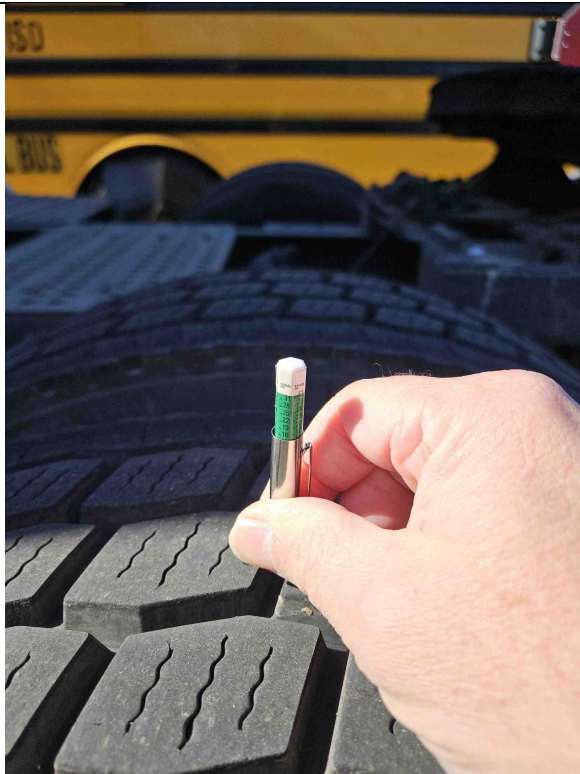

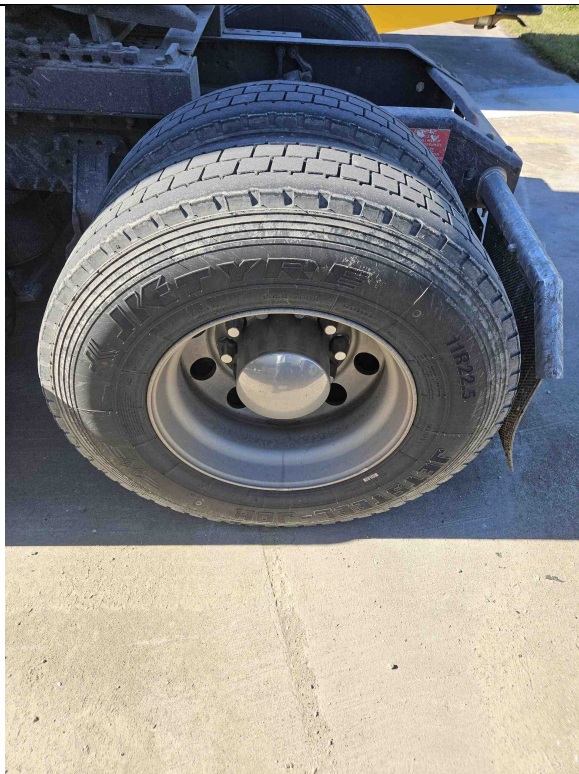

Depth @ 8/32nds

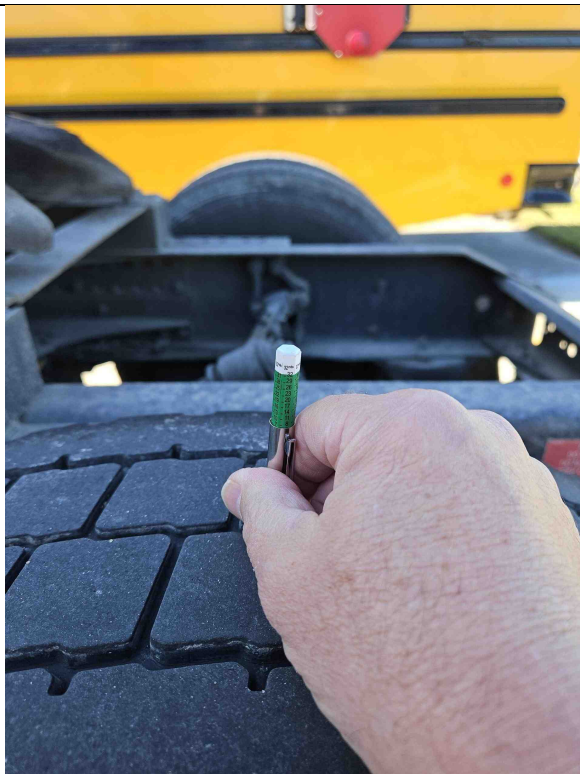

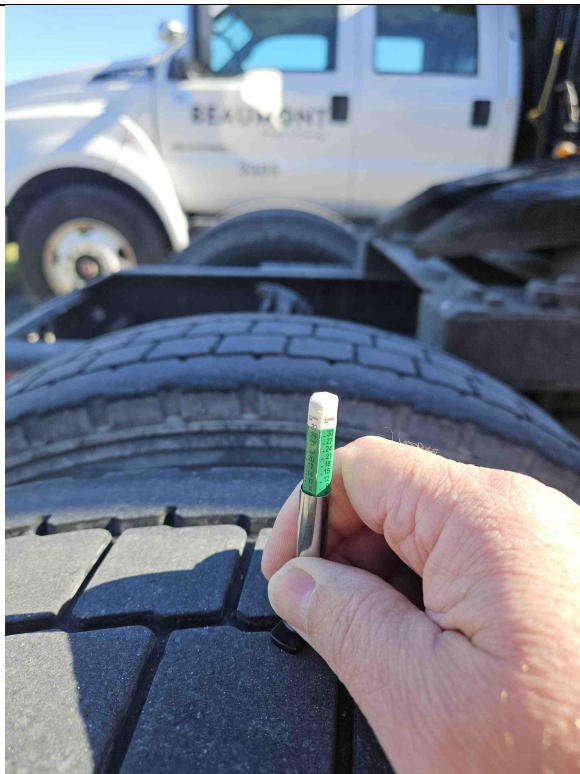

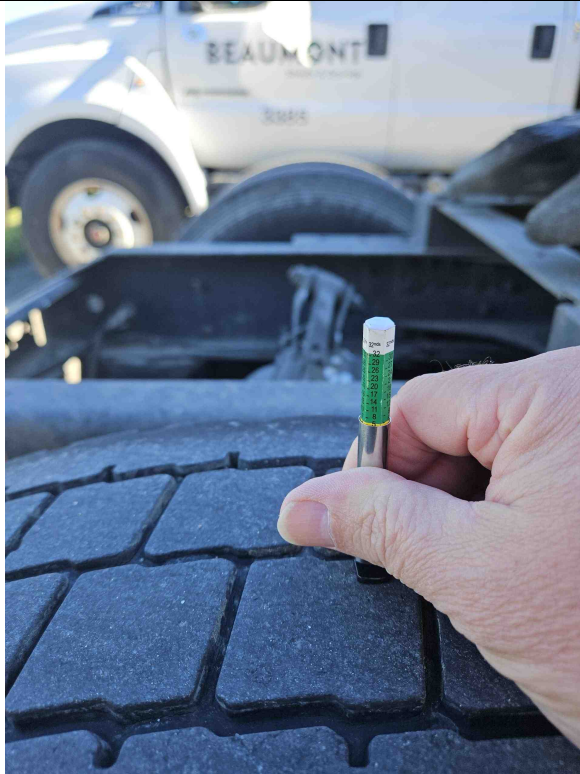

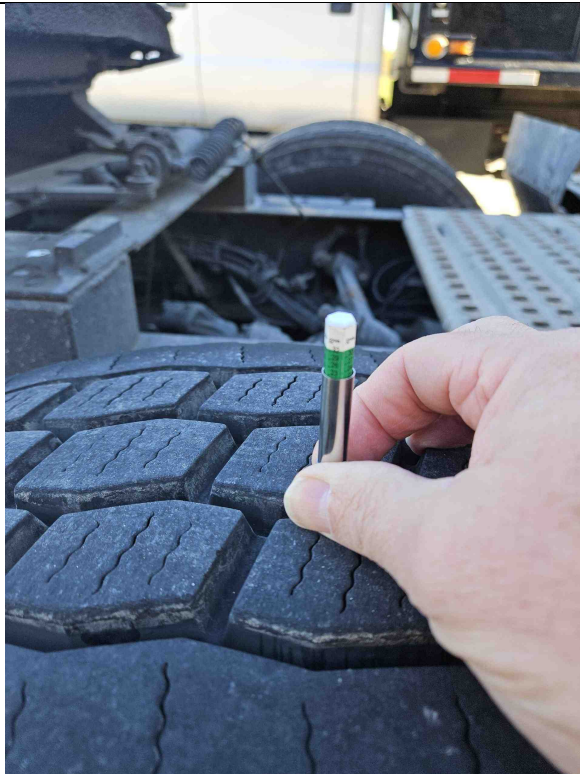
