## **COLLISION REPAIR AGREEMENT**

### **Terms and Conditions Governing Estimate**

This Collision Repair Agreement ("CRA") is entered into as of the date of signature of collision repair estimate ("Estimate") to which this CRA is attached ("Effective Date") between Penske Truck Leasing Co. L.P. ("Penske") and the entity signing the attached Estimate ("Customer"). This CRA is and shall form a part of the collision repair estimate provided by Penske to Customer.

**1. Term & Termination.** This CRA shall commence on the Effective Date and shall continue until terminated upon written notice by one party to the other, or until the work for a particular vehicle ("Vehicle") has been completed, whichever occurs first.

**2. Services.** The repair, replacement, and any other services performed by Penske in connection with collision repair on the Vehicle shall constitute the "Services" under this CRA. Unless otherwise set forth in a CRA Pricing Addendum, Services will be billed to Customer at rates and charges set forth in the collision repair estimate, which reflect then-current parts and labor pricing which will vary over time. In the event that in the course of the Services, Penske discovers additional damage or necessary work that was not within the scope of the estimate, Penske may proceed with such additional repairs at Customer's expense so long as the Charges additional work or repairs does not exceed ten percent (10%) of the estimated Charges; if the additional Charges would exceed this threshold, Penske will provide Customer with a revised estimate. Any Services performed by third parties will be billed at the third party's invoice price, plus a reasonable markup. Any fuel or diesel exhaust fluid provided by Penske to Customer shall be at prices that vary over time. All Services performed by Penske shall be done in a good and workmanlike manner ("Performance Standard"). If within thirty (30) days of completion of a Service, Customer gives Penske written notice that it believes a Service was not performed in accordance with the Performance Standard, Penske will review the notice in good faith and endeavor to work with Customer to address such concern.

**3. Charges.** As used in this CRA, "Charges" means the charges for the Services, shop supplies, and any and all other amounts and charges described elsewhere in this CRA, as well as all taxes and assessments that are now in force or may hereafter be levied on the Vehicles or Services. Customer shall pay Penske all Charges, in the form of checks or electronic funds transfer, within seven (7) days of the date of Penske's invoice, without deduction or offset. Unless Customer protests the correctness of any invoice within thirty (30) days of its receipt, such invoice shall be presumed to be correct. Customer shall be charged interest at 1.5% per month for any outstanding Charges. Penske shall be entitled to reimbursement from Customer of all expenses of collection and reasonable attorneys' fees (including those incurred on any appeal) spent in addressing any Customer breach.

**4. Damage.** Customer assumes the risk of loss or damage (physical or otherwise) to all Vehicles from any and every cause whatsoever, including, but not limited to, casualty, collision, upset, deterioration, structural failure, fire, theft, malicious mischief, vandalism, graffiti, glass breakage, and mysterious disappearance. Penske shall have no obligation to repair such damages.

**5. Insurance.** Customer shall, at its expense, maintain Automobile Liability Insurance with a combined single limit of not less than \$1,000,000 per occurrence for each Vehicle for liability or bodily injury, death or property damage arising out of the ownership, maintenance or operation of such coverages, shall be primary and non-contributory. The limits of coverage shall not be considered a limitation of liability. Upon request, Customer shall deliver to Penske a certificate of insurance showing the coverage required pursuant to this paragraph.

**6. ## **COLLISION REPAIR AGREEMENT**

### **Terms and Conditions Governing Estimate**

This Collision Repair Agreement ("CRA") is entered into as of the date of signature of collision repair estimate ("Estimate") to which this CRA is attached ("Effective Date") between Penske Truck Leasing Co. L.P. ("Penske") and the entity signing the attached Estimate ("Customer"). This CRA is and shall form a part of the collision repair estimate provided by Penske to Customer.

**1. Term & Termination.** This CRA shall commence on the Effective Date and shall continue until terminated upon written notice by one party to the other, or until the work for a particular vehicle ("Vehicle") has been completed, whichever occurs first.

**2. Services.** The repair, replacement, and any other services performed by Penske in connection with collision repair on the Vehicle shall constitute the "Services" under this CRA. Unless otherwise set forth in a CRA Pricing Addendum, Services will be billed to Customer at rates and charges set forth in the collision repair estimate, which reflect then-current parts and labor pricing which will vary over time. In the event that in the course of the Services, Penske discovers additional damage or necessary work that was not within the scope of the estimate, Penske may proceed with such additional repairs at Customer's expense so long as the Charges additional work or repairs does not exceed ten percent (10%) of the estimated Charges; if the additional Charges would exceed this threshold, Penske will provide Customer with a revised estimate. Any Services performed by third parties will be billed at the third party's invoice price, plus a reasonable markup. Any fuel or diesel exhaust fluid provided by Penske to Customer shall be at prices that vary over time. All Services performed by Penske shall be done in a good and workmanlike manner ("Performance Standard"). If within thirty (30) days of completion of a Service, Customer gives Penske written notice that it believes a Service was not performed in accordance with the Performance Standard, Penske will review the notice in good faith and endeavor to work with Customer to address such concern.

**3. Charges.** As used in this CRA, "Charges" means the charges for the Services, shop supplies, and any and all other amounts and charges described elsewhere in this CRA, as well as all taxes and assessments that are now in force or may hereafter be levied on the Vehicles or Services. Customer shall pay Penske all Charges, in the form of checks or electronic funds transfer, within seven (7) days of the date of Penske's invoice, without deduction or offset. Unless Customer protests the correctness of any invoice within thirty (30) days of its receipt, such invoice shall be presumed to be correct. Customer shall be charged interest at 1.5% per month for any outstanding Charges. Penske shall be entitled to reimbursement from Customer of all expenses of collection and reasonable attorneys' fees (including those incurred on any appeal) spent in addressing any Customer breach.

**4. Damage.** Customer assumes the risk of loss or damage (physical or otherwise) to all Vehicles from any and every cause whatsoever, including, but not limited to, casualty, collision, upset, deterioration, structural failure, fire, theft, malicious mischief, vandalism, graffiti, glass breakage, and mysterious disappearance. Penske shall have no obligation to repair such damages.

**5. Insurance.** Customer shall, at its expense, maintain Automobile Liability Insurance with a combined single limit of not less than \$1,000,000 per occurrence for each Vehicle for liability or bodily injury, death or property damage arising out of the ownership, maintenance or operation of such coverages, shall be primary and non-contributory. The limits of coverage shall not be considered a limitation of liability. Upon request, Customer shall deliver to Penske a certificate of insurance showing the coverage required pursuant to this paragraph.


